*The majority of Syracuse Scenery projects require payment of State established and published Prevailing Wage rates for work on project sites. The rates vary by geographic location of the project and type of work. The majority of the Company's work takes place in New York State. Project work also takes place in other states. Prevailing Wage Rate may be lower in other states. For most states, Prevailing Wage rates are changed once each year. The company complies with all state prevailing wage requirements. The company's installation employees are paid as journeyman, typically Carpenter-Building rate, or Electrician rate; depending on the specific work performed. Prevailing wages have 2 components: Wages Per hour, and Supplemental Benefits Per Hour. For the \$47.55 wage rate listed above (NY – Allegany County Building Carpenter), \$27.55 is the Wage Per hour and \$20.00 is the Supplemental Benefits per hour. For the \$104.55 wage rate listed above (NY-Westchester County Electrician) \$52.75 is the Wage per hour and \$51.800 is the Supplemental Benefits per hour. The total of weekly Supplemental Benefits are deposited each week into each employee's owned 401(k) Fringe benefit plan. Plan description documents are available for review. Company employees frequently work on more than one Prevailing Wage rate project during a week. An employee's pay check may include payment for 5 – 10 different hourly rates.
